1. A "dose" is defined as a single insemination unit. Frozen semen is sold per dose with no explicit or implied guarantee of conception or a live foal.
2. Semen is stored and shipped by Pioneer Equine Hospital, a Select Breeders Services affiliate.

3. Detailed thawing and handling instructions for the frozen semen is provided with doses.
4. A signed contract and full payment is required before Seller will authorize release of semen by Pioneer. Seller will send Shipment Authorization to Pioneer as soon as the contract and payment are received.
5. Buyer must submit a Shipment Request form to Pioneer along with the required payment for shipment. The Request form will be provided by the Seller.
6. All sales are subject to availability and are final upon acceptance of this Agreement.
7. Buyer is responsible for all shipping, tank rental and handling fees associated with delivery of the semen from the storage facility and return of the shipping container. *For US recipients, Pioneer estimates \$600-700 total cost for the mare owner. This includes **shipping costs there and return** for vapor shipper, vapor shipper rental, and handling fee.*
8. Once the shipment arrives it should be inspected immediately. Any claims regarding the integrity of the shipment must be filed within 24 hours of delivery.
9. Seller shall not be responsible for lost semen shipments or delays in delivery not within the control of the Seller such as missed flights, weather delays, failure of third party service, or acts of God.
10. Buyer must contact the seller to request semen use on a mare other than the mare specified. This would, include breeding a different mare with additional/unused doses following a successful breeding of the named mare.
11. Buyer is strongly encouraged to notify the Seller of pregnancy/pregnancies and to register off-spring with the Irish Draught Horse Society of North America (IDHSNA). The Seller will happily provide assistance for registration. All offspring regardless of mare's breeding are eligible for inspection with IDHSNA. See [irishdraught.org](http://irishdraught.org).
